If it is not provided, the undersigned agrees to purchase a Rental Protection Plan (sometimes referred to as 'damage waiver') at a charge of up to 12% of the cost of rentals. A service charge of up to 2.0% per month will be imposed on all past due amounts. The undersigned will pay all costs of collection, including any attorney's fees. **The undersigned hereby consents to the exclusive jurisdiction of any state or federal court situated in Dane County, Wisconsin, with respect to all claims by or against FABCO, and any state or federal court situated in Milwaukee County, Wisconsin, with respect to all claims by or against LCS. The undersigned hereby waives any objection based on lack of personal jurisdiction, improper venue or forum non conveniens, with regard to any actions, claims, disputes or proceedings relating to the applicable credit agreement, rental agreement, and other contract documents, or any transaction arising from or connected to any of the foregoing. The undersigned waives personal service of process, and consents to service of process made by mail or messenger directed to it at the billing address set forth above.** Nothing herein shall affect the right of FABCO and/or LCS to serve process in any manner permitted by law, or to limit the right of FABCO or LCS to bring proceedings against the undersigned or its property or assets in the competent courts of any other jurisdiction or jurisdictions.
